**NGB Secure FTP from IATS to ODS**

The ODS sFTP user accounts lock after 30 days of inactivity. To ensure your ODS sFTP account does not lock, it is suggested you log into IATS, from the Sys Admin screen click "Download From Mainframe" and then "Download Transactions from Disbursing System". You may not have anything to download, but the system will connect to the ODS sFTP site to restart your 30 day clock. IF you can't upload or download and it's been more than 30 days since you did either, you will need to contact the ODS Help desk to unlock your account. **NGB Uploads**

The IATS System Office has been posting the NGB site's uploads to the ODS secure FTP site since July 20th. This courtesy was to allow each site time to request and receive their own ODS secure FTP user account and then configure IATS and WinSCP. Due to NetIATS testing and certifying FISCAM controls, the IATS System Office will no longer post

upload files to the ODS secure FTP site effective Monday, February 1, 2016.

The IATS System Office and the IATS Help Desk will continue to assist in configuring IATS and WinSCP once the site has received their ODS secure FTP user ID; should be upgraded to IATS 6.21.3 or higher; and installed a WinSCP version 5.7.4, 5.7.5 or 5.7.6.
