Current IATS Release is 7.0.1 for Army and COE, Navy and USMC are still using 7.0.

IATS 7.0.1 was mailed on October 20<sup>th</sup>, 2018. To install the 7.0.1 software, follow the directions in the 701SVD.PDF file found in the root folder on the accompanying CD. If you have questions, contact the Help Desk.

**NOTE: DTOD 31 does not support XP machines. Do not remove your DTOD 28 on your XP machines.**

## ***\*\* End of Life for IATS 6.x \*\****

All versions of IATS 6.x will no longer be supported after January 31, 2019. The IATS 7.x generation was released in late January 2018, so it's no longer feasible to support both generations of IATS. IATS 6.x was written in Visual Basic 6 (VB6) which is no longer supported, so it's making the IATS 6.x more difficult to support. Please upgrade to IATS 7.x as soon as possible. ## ***\*\* Screen Resolution \*\****

IATS 7.1 is due to be released in early 2019. The screens have been enlarged, so users' PCs will be required to have a minimum screen resolution of 1920 x 1080 to see all screens.

# IATS 7.0.1

This interim change package incorporates tax changes propagated through Public Law 115-97, known as the “2018 Tax Cuts and Jobs Act” which repealed moving expenses deduction (26 U.S.C. § 217) along with the exclusion reimbursements and payments of moving expenses (26 U.S.C § 132(g)) effective January 1, 2018. As a result, certain expenses listed in FTR § 302-17.8 that was previously considered as not taxable will now become taxable, which effectively means that all civilian relocation entitlements are now fully taxable.

This release also corrects issues presented in previous versions of IATS 7.X regarding the posting of CCV’s, as well as the processing of certain TDY supplementals and finally Lump Sum TQSE involving OCONUS to CONUS or CONUS to OCONUS CIVPCS travel.

**You must either be currently on version 7.0, or 7.0.0 before installing 7.0.1. If you are not on version 7.0 please install that change package and then install 7.0.1.
